## **Explanation of Responses:**

- 1. As previously reported, on June 1, 2015, the reporting person was granted 15,511 restricted stock units (RSUs) under the Navient Corporation 2014 Omnibus Incentive Plan representing the right to receive shares of Navient common stock in the future, which vest in one-third increments on each of the first, second and third anniversaries of the grant. On June 1, 2018, 5,170 shares of such RSUs were settled and an additional 763.9737 shares were issued to the reporting person upon the vesting of the related dividend equivalent rights. In connection with this settlement, 2,647 shares were withheld by Navient (as approved by the Navient Compensation and Personnel Committee) to satisfy the reporting person's tax withholding obligations.
- 2. Dividend equivalent rights issued on RSUs and performance stock units are included in the reporting person's common stock holding balance.
- 3. Reflects the disposition of 0.9737 shares settled in cash upon the delivery of the related dividend equivalent rights, in accordance with the terms of the 2014 Navient Corporation Omnibus Incentive Plan.
