**Explanation of Responses:**

- As previously reported, on May 1, 2014, Mr. Chivavibul was granted 11,764 restricted stock units ("RSUs") under the Navient Corporation 2014 Omnibus Incentive Plan representing the right to receive shares of Navient common stock in the future, which vest in one-third increments on May 1, 2015, May 1, 2016 and May 1, 2017. On May 1, 2015, 3,921 shares of such RSUs were settled and an additional 125 shares were issued to Mr. Chivavibul upon the vesting of the related dividend equivalent rights. In connection with this settlement, 1,952 shares were withheld by Navient (as approved by the Navient Compensation and Personnel Committee) to satisfy Mr. Chivavibul's tax withholding obligations.
- Dividend equivalent rights issued on RSUs and performance stock units are included in Mr. Chivavibul's common stock holding balance.
- Between February 18, 2015, and April 30, 2015 Mr. Chivavibul acquired 166.05 share equivalents of Navient common stock under the Navient 401(k) Savings Plan. The information in this report is based on the reporting person's actual account balance as of April 30, 2015.
